Arizona	HB 2589	Would allow faculty to carry a concealed weapon	Bill Failed	6/14/13
Arkansas	HB 1243	Would allow faculty to carry a concealed weapon. Schools an opt out on annual basis	Signed by Governor Over 35 colleges have opted out as 6/17/13	5/17/13
Colorado	HB 1226	Would allow colleges to decide if they want concealed weapons on campus	House bill passed, bill not brought up by Senate	5/8/13
Georgia	SB 101	Would force colleges to accept concealed weapons on campus, also allow concealed weapons in sensitive places of Hartsfield/Jackson Airport and allow concealed weapons in houses of worship	Defeated, but can be voted on in Jan. 2014 by Senate	3/28/13
Indiana	H 97	Would prohibit a state agency, including a state supported college or university, from regulating concealed weapons on land or in buildings and other structures that are owned or leased by the state.	Bill Failed	4/27/13

Kansas	HB 2052	Would force colleges and universities to permit concealed weapons on campus. Schools can opt out for up to 4 years.	Signed into law	Projected 6/20/13
Michigan	SB 213	Would allowed concealed weapons on campus and eliminates licensing boards.	Pending in Natural Resources Committee (same bill vetoed by Gov. in 2012)	12/31/13
Missouri	HB 70	Allows a teacher or school administrator to carry a concealed firearm into a higher education institution or elementary or secondary school if he or she has a valid concealed carry endorsement or permit	Referred to General Laws Committee	5/30/13
Montana	HB 240	Would remove authority from Board of Regents to regulate possession of concealed weapons on campus.	Bill Vetoed by Gov.	4/24/13
Nevada	AB 143 SB 223	Would allow concealed weapons on campus without permission of schools.	Bills defeated in Committee	6/3/13
North Carolina	H937	Would allow carrying of concealed weapons on campus, at funerals, parades, in bars & restaurants.	Passed House, Passed Senate – sent back to House	Expected 8/7/13
Tennessee	S 242	Would allow certain persons employed by a state institution of higher education as a faculty or staff member to possess and carry a handgun at the state institution of higher education while performing official duties	Defeated	4/19/13
Texas	SB 1907	Would allow concealed weapons to be stored in locked vehicles in parking lots	Guns in parking lots signed 6/17/13	In Special Session
